1. 280 Overlay Follow Up with Lindsey Puckett

Lindsey Puckett was phoned into the meeting to review and clarify questions the board has. The board reviewed question one in regards to removing parcels that seems out of place. Mrs. Puckett and the board agreed to remove parcel number one. The board went on the discuss question two – difference in commercial laundry and dry cleaners. Mrs. Puckett confirmed dry cleaners would fall under personal services. Mrs. Puckett also explained makerspace as a work, studio and/or retail space for artisans, craftsmen or small scale manufactures. Chairman Sanders requested Lindsey add the definition to appropriate documents.

The board went on to discuss questions and get clarification from Lindsey as it pertains to the overlay district. The board discussed what date would be ideal to hold the public meeting for the overlay district.
