DEPARTMENT AND COMMITTEE REPORTS

Police Department:

Police Chief Jimmy Macon stated the department received 457 calls for service for the month of September and issued 236 citations. Chief Macon asked all citizens to please follow the traffic laws especially those which apply to school buses.

Fire Department:

Firefighter Felix Dunn stated the burn ban is still in effect and encouraged everyone to practice common sense once the burn ban is lifted.

REQUESTS TO ADDRESS THE COUNCIL

1. Shelby County Arts Council

Bruce Andrews, Executive Director, addressed the council. Mr. Andrews said they are nearing completion on The Shelby County Arts Center (SCAC). This will be the centerpiece of a 30,000 square foot municipal complex. SCAC will occupy 20,000 square feet of the complex exclusively. The project is made possible by collaboration between Shelby County, the City of Columbiana, and The Shelby County Arts Council. He stated he wants all municipalities to be a part of this endeavor and partner with one another. He said this is achieved by all the partners sharing and attending each other's events. He thanked the council for their time and for allowing him to speak tonight.

2. Jennifer Cardwell, The Meadows at Harpersville

Mrs. Cardwell was not in attendance due to an unforeseen circumstance.

3. Dr. Michele Edwards, Principal, Vincent Middle High School

Dr. Edwards thanked the council for the opportunity to speak tonight. She stated the information before the council included a culmination of capital improvement items which was created with input from the faculty and staff. She said she is seeking financial assistance from the municipalities of Harpersville, Westover, and Vincent. She clarified the school is comprised of students from these communities. One of the projects the school is undertaking is the construction of a student training facility which will be utilized by all sports and physical education classes. It is the goal of the school to have this facility ready for student use in the summer of 2020. Vincent Middle High School senior J.T. Youngblood addressed the council and spoke to the need of this facility. He mentioned this facility will be a great addition to the school and community. Dr. Edwards stated the coaches and staff will all be certified for weight and strength conditioning programs. The facility will also house the school's athletic trainer. Dr. Edwards thanked Mayor Greene and the council for their time and consideration.
