CALL TO ORDER, INVOCATION, AND PLEDGE OF ALLEGIANCE

It was noted for the record the Harpersville Municipal Court account summary report for the month of August 2020 was provided to the town council.

DEPARTMENT AND COMMITTEE REPORTS

Police Department:

Police Chief Jimmy Macon stated the police department received 415 calls for service during the month of August 2020. He stated he has instructed the police officers not to issue verbal warnings. He added this would allow for better record keeping as all written warnings are submitted to the State of Alabama. Councilmember Dates asked about the police officer currently on unpaid leave status. Chief Macon stated a meeting has been set with the employee for Friday, September 11, 2020.

Fire Department:

Firefighter Mark Lewis stated there has been confusion in the community about the burn ban implemented by the Alabama Department of Environmental Management (ADEM). He said in Shelby County the burn ban is in effect from April 1 to October 31, with no exceptions. He noted the hot summer weather brings drier conditions, which are a concern for fires being started more easily. He said the overall intent of the ban is to improve the air quality. Mr. Lewis suggested the town adopt an ordinance to give the fire and police departments the authority to cite citizens who violate the burn ban.

Mayor-elect Perkins stated he believes being able to educate the public, more would be helpful prior to adopting an ordinance.

Library:

It was noted the written library report from July 2020 was given in advance of the council meeting.

PROCLAMATIONS BY THE MAYOR

Mayor Greene, by proclamation, declared September 28, 2020 as Family Day and the week of September 27 through October 3, 2020 as Family Week in Harpersville, Alabama. Mayor Greene added while the town will observe Family Day on September 28, 2020, everyday should be family day.

1. **Resolution 2020-09-08-01** for consideration to affirm the hiring of two (2) new part-time employees for the Harpersville Fire Department was introduced by Mayor Greene.

Councilmember Gill stated the public safety committee met with both applicants and were impressed by their qualifications. Councilmember Dates said the two applicants would make great additions to the fire department.

3. **Resolution 2020-09-08-03** for consideration to conditionally agree to terms with Veterans Village for the sale of real property was introduced by Mayor Greene.

Councilmember Gill moved to adopt Resolution 2020-09-08-03 and Councilmember Dates seconded the motion.

Mayor Greene said the agreed upon sale price for the property is \$220,000.00. He added the option for the new property boundary lines is not in the best interest of the town and has asked these to be updated.

He noted an ordinance declaring the property as surplus and a sales agreement authorizing the sale of the property will still be necessary.

Councilmember Rayfield thanked Mayor Greene for his comments and said 70 years has gone by in a hurry. He said the Lord has blessed him with almost 90 years and 70 of those with his wife. Mrs. Rayfield thanked Mayor Greene and said they have had a good marriage, good kids, and a good many years.

Mayor-elect Perkins stated he is looking forward to working again as the Mayor of Harpersville.

Councilmember-elect William Carter said it was will be difficult to fill Councilmember Rayfield's shoes, but he is excited to serve.
