#### DEPARTMENT AND COMMITTEE REPORTS

### Police Department:

Police Chief Jimmy Macon encouraged all citizens to ensure firearms are secured and locked away when not in use. He clarified by saying stolen firearm cases have risen in recent weeks. He said an AK-47 was stolen in Harpersville and later found by law enforcement in San Antonio, Texas. Chief Macon urged citizens to exercise caution and obey the speed limit on U.S. Highway 280.

# Fire Department:

Fire Chief Heath Confer noted a burn ban was still in place until October 31, 2020. He noted during the warm summer months, humid weather does not allow for proper ventilation, especially from smoke. He said the burn ban is to protect the air quality. Chief Confer said the new fire apparatus would be in service once the final equipment is received and installed by the manufacturer.

Chief Macon echoed Councilmember Dates' comments and said Ms. Head met 99.9% of the qualifications on the job description.
