APPROVAL OF TOWN COUNCIL AGENDA

Councilmember Carter made a motion to approve the Town Council agenda for January 04, 2021. Councilmember Gill seconded the motion. The motion passed unanimously by voice vote of those members of the Council present, and Mayor Perkins declared the same passed.

REQUEST(S) TO ADDRESS THE COUNCIL:

1. **Resolution 2021-01-04-01** for consideration to approve or deny certain items as surplus property and to employ Pearce & Associates to auction said surplus items for the Town of Harpersville was introduced by Mayor Perkins.

Councilmember Gill moved to adopt Resolution 2021-01-04-01 and Councilmember Carter seconded the motion.

The motion to adopt Resolution 2021-01-04-01 passed unanimously by voice vote of those members of the Council present, and Mayor Perkins declared the same passed.

2. **Resolution 2021-01-04-02** for consideration to approve or deny the payment of \$5,268.70 to Owen Arts Studio for the reconstruction, materials, labor and installation of the Highway 280 East welcome sign which was damaged/destroyed in the October 2020 storm was introduced by Mayor Perkins. The Mayor explained the Town's insurance policy will reimburse all but approximately \$1,040.00 of the cost.

Councilmember Carter moved to adopt Resolution 2021-01-04-02 and Councilmember Gill seconded the motion.

The motion to adopt Resolution 2021-01-04-02 passed unanimously by voice vote of those members of the Council present, and Mayor Perkins declared the same passed.
