DEPARTMENT AND COMMITTEE REPORTS

Fire Department:

Fire Chief Heath Confer reported on the following items:

- The Harpersville Fire Department recently applied for a grant from Fire House Subs. They are one month into a two month waiting period.
- The Fire Department is in the process of applying to the FEMA Assistance to Firefighters Grant Program. Chief Confer stated they are looking to apply with several other departments from the surrounding community to make one regional application. He said this method has yielded positive results in the past.
- Engine 302 is running and operating well after extensive repairs. Research is being conducted to potentially replace the older apparatus. This process coincides with Mayor Greene's Five Year Capital Improvement Plan.

Library:

Library Director Marsha Moore stated the 2019 Summer Reading program is going well and noted having had over 30 kids and adults attend. She noted this week will feature a representative from the Space and Rocket Center and puppets the following week.

Police Department:

Police Chief Jimmy Macon reported there was a recent car fire in town. He stated the investigation is still ongoing, but it is believed the fire might be a result of arson.
