1. **Resolution 2021-06-07-01** to approve or deny the Back-to-School Tax Holiday on July 16-18, 2021.

Councilmember Dates moved to adopt Resolution 2021-06-07-01 and Councilmember Carter seconded the motion.

Councilmember Rich moved to adopt Resolution 2021-06-07-03 and Councilmember Dates seconded the motion.

The motion to adopt Resolution 2021-06-07-03 passed unanimously by voice vote of those members of the Council present, and Mayor Pro Tem Gill declared the same passed.

4. **Resolution 2021-06-07-04** to approve or deny Elbert Buckelew's request to vacate the road running through his property located along U.S. Highway 280, further described as Parcel ID #17-1-02-0-000-001.000.
