### CALL TO ORDER, INVOCATION AND PLEDGE OF ALLEGIANCE

Mayor Perkins called the meeting to order at 5:33 p.m. Marsha Moore led the invocation. The Pledge of Allegiance was led by Chief T.E Smith.

#### APPROVAL OF TOWN COUNCIL AGENDA

Councilmember Johnson made a motion to approve the Town Council Agenda for March 06, 2023. Councilmember Gill seconded the motion. Mayor Perkins declared motion passed unanimously.

DEPARTMENT AND COMMITTEE REPORTS

#### Police Department:

Police Chief Smith did not have reports to submit before the council but he wanted to speak on behalf of the public safety work session held February 27, 2023. Chief Smith wanted to follow up with the council and make sure they did not have additional questions. He also informed them that at the end of 2021 the Police Department had ten employees on payroll and as of now there are currently six. He expressed how personnel is an issue for the growing city and urged the council to hire more officers. Chief Smith also requested a working list of council contact as well as active employees to have when needed.

#### Planning and Zoning

David Sanders was present and addressed the council about short term rental properties within the Town of Harpersville and the concerns that surround it. He informed the board that the Planning and Zoning committee addressed the issues in their last meeting and they have spoken to the attorney. At this time they are waiting on information from the attorney to let them know how to move forward. Councilmember Gill asked Mr. Sanders to explain what he means by short term rental. Mr. Sanders answered that he means two to three day rentals or something that would be considered Air B&B.

1. Councilmember Rich requested at update on where the Town is with paving

Mayor Perkins let her know there is no update. As, the town is still waiting on quotes and working with the Engineer.

# NEW BUSINESS / RESOLUTIONS / ORDINANCES / ORDERS and OTHER BUSINESS

1. Resolution 2023-03-06-06 for consideration to accepts a quote for the repair and/or maintenance of the A/C units at the Community Center

The council discussed all the quotes that were provided for the maintenance on the A/C units. Councilmember Dates recommended Sleeping Giant because he is familiar with their work and knows they will do a good Job. Councilmember Carter said he feels the other quotes are higher simply because of the brand name on the unit. The council asked the Mayor for his thoughts and he responded that he was familiar with Skelton's and Councilmember Dates was familiar with Sleeping Giant. Mayor Perkins thought either company would be a good choice for what the council was trying to accomplish.

Councilmember Carter moved to accept Sleeping Giants quote in the amount of \$9,933.00 and Councilmember Dates seconded the motion with Mayor Perkins opposing: Mayor Perkins called for a voice vote and declared motion passed.

1. Councilmember Gill made a motion to allow the electrical cost from the pole mounts and the rental cost of the bucket truck to be taken out of another account within the town budget and not from the Christmas budget. Councilmember Carter second the motion. Mayor Perkins declared motion passed unanimously.
