1. **Resolution 2023-03-20-01** for consideration to accept maintenance agreement for 12 units from Air Experts.

Council Member Gill voted to adopt resolution 2023-03-20-01 and enter into a maintenance agreement with Air Experts to service 12 a/c unity bi-annually. Council Member Johnson seconded the motion. Mayor Perkins called for a voice vote and declared motion passed.

1. **Resolution 2023-03-20-02** for consideration to accept quote for the repair and maintenance of the roof at the Community Center

Council Member Gill moved to adopt resolution 2023-03-20-02 and accept the quote from David Metal Roofing. Councilmember Carter seconded the motion. Mayor Perkins called for a voice vote and declared motion passed.

2. To delegate a voter and alternate for the Alabama League of Municipalities Convention.

Councilmember Gill made a motion to designate Mayor Perkins as the voting delegate and Councilmember Carter as the first alternate. Councilmember Dates second the motion. Mayor Perkins called for a voice vote and declared motion passed.

3. Councilmember Gill presented an invoices for the logo to go behind the council bench and commercial style benches and trashcans.

Councilmember Gill made a motion to approve spending up to \$1,800.00 on the art work for the Town logo for behind the bench. Councilmember Dates seconded the motion. Mayor Perkins called for a voice vote and declared motion passed.

Councilmember Gill made a motion to approve \$2,000.00 split between the town of court department for the purchase of commercial style benches and trashcans to go outside of the community center building. Councilmember Rich second the motion. Mayor Perkins called for a voice vote and declared motion passed.
