DEPARTMENT AND COMMITTEE REPORTS:

- 1. Library report for the month of May 2023 were presented before the council
- 2. Court reports for the month of May 2023 were presented before the council
- 3. Fire Chief Confer was present. He informed the council of the issue at the fire station. They recently had sewage back up into the building. Chief Confer let the Council know they have a third party tending to the issue and he believes the station needs a bigger pump. Mayor Perkins stated he will contact Enviro Systems and discuss a previous agreement the Town has with them regarding the size of the pump.
 - Councilmember Dates asked Chief for an update in regards to the painting of the fire hydrants. Chief Confer informed the council the department will spray the FH and they are waiting on all the rain to move out.
 - Chief Confer also reminded the council and guest that the Town of Harpersville is still under a burn ban until October 2023
- 4. Police Chief Smith presented the police department reports for May 2023. Chief Smith went over the report and opened the floor for questions.
 - Councilmember Gill asked about the job posting for new Police Officer. She wanted to know if we have had any responses. Chief Smith replied we have two possible candidates and hope to have a few more apply.
 - Chief Smith also announced the department will be hosting a "Police and Pizza" night this coming Thursday, June 22^{nd} in the Community Center form 6-7:30pm.
