Fire Department:

Fire Chief Heath Confer encouraged all citizens to stay hydrated and to seek immediate medical attention if your body begins to show signs of dehydration. He stated a burn ban is still in effect. He clarified the burn ban is not always to prevent wildfires, but to improve the air quality.

Police Department:

Police Chief Jimmy Macon stated while the speed limit has not changed on U.S. Highway 280 through Harpersville, the police department has seen a rise in excessive speeding. He asked for citizens to please abide by the posted speed limit. Chief Macon said gunshots were fired in town on the evening of Sunday, August 18, 2019. He said the Harpersville Police Department provided backup support to the Shelby County Sheriff's Office.
