1. Resolution 2023-08-21-01 – To enter into contract with Dial My Name **OR** Everbridge for a mass communication system for our community

Councilmember Gill made motion to enter into an agreement with Everbridge for the service of mass communication. Councilmember Carter added that the quote be taken to the Water Department for approval to pay for half the annual cost. Councilmember Carter then seconded the motion. 2. Resolution 2023-08-21-02 – To approve hiring Angela Tait and Robert Price for the position of Police Officer at the Harpersville Police Department

Councilmember Shelia Rich made motion to offer employment to Angela Tait and Robert Price for the position of Police Officer at the Harpersville Police Department. Councilmember Carter seconded the motion. By voice vote, motion passed unanimously. Mayor declared the same

3. Resolution 2023-08-21-03 To approve buyout amount to hire Jordan Deaver as a Police Officer for the Harpersville Police Department pending interview and proper screening

Councilmember Gill made a motion to proceed with the buyout of Officer Jordan Deaver's contact with UAB pending an interview. Councilmember Dates seconded the motion. By voice vote, motion passed unanimously. Mayor declared the same

4. Ordinance 2023-08-21-04 – To approve the annexation request of Parcel 07-4-18-0-000-050.000 from Golden Eagle Group

Councilmember Carter made a motion to approve unanimous consent of the annexation application of the Golden Eagle Group with parcel identified as 07-4-18-0-000-050.000. Councilmember Dates seconded the motion. The motion passed unanimously by roll call vote of those members of the Council present as follows:
