#### NEW BUSINESS

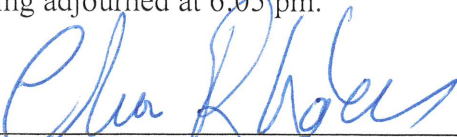
- A. Reviewed and discussed the PFAS Monitor Report
